- Payment after May 4, 2011 will **only** be accepted in the form of a certified cheque, money order or cash. There is a \$25.00 charge for cheques that are returned as NSF (non-sufficient funds).
- There is a cancellation fee of \$25.00 between April 14 - May 14, 2011
- No refunds will be provided after May 14, 2011.
- After May 14, 2011 there will be a charge of \$25.00 for any switching of players.
- In order to be fully registered for the 2011 outdoor soccer season, this form must be properly signed and a cheque, money order or cash for the full amount must accompany this form
- Any modification to the wording of this registration form will result in an unprocessed application.

Agreement and Signature

All registered players understand, accept and agree that as a condition of their participation in any activity organized by MAPLE LEAF SOCCER CLUB, a division of J&L ATHLETICS INC. that he or she will truly save, defend and fully indemnify the said league from and against all manner of actions, suits, claims and demands which may be brought against or made upon it and against all loss, cost damages or other expenses which it may sustain, suffer, incur or be liable for as a result of their participation in any league activity.

It is clearly and unmistakably understood by the team representatives who constitute THE ORGANIZING COMMITTEE on behalf of their Teams, that he or she have a responsibility to inform each and every member of their respective team of the aforementioned condition for participation in activities organized by MAPLE LEAF SOCCER CLUB, a division of J&L ATHLETICS INC. and to further obtain and file a signed indemnification agreement to this effect from each member.

It is clearly and unmistakably understood by every player participating in MAPLE LEAF SOCCER CLUB, a division of J&L ATHLETICS INC., that they do so of their own free will and volition and fully cognizant of its rules and regulations and that he or she agree to abide by same.

Further, it is understood that all decisions by the referees regarding the issuing of cards and/or the sending off of players in a match are final and may not be disputed with the league. **Players receiving a red card (or 2 accumulated yellow cards throughout the season) will be required to pay a \$25 fine. Subsequent yellow cards will incur a \$25 fine, and a red card will incur a \$50 fine.** Players receiving a red card will also be penalized for one game following the date of the infraction. It is understood that a player receiving 3 accumulated red cards will be expelled from the league. **Suspensions and fines may be increased at the League Organizer's discretion.** It is understood that any unpaid fines as a result of the issuing of a card during a match from a referee will result in a suspension from playing in any further games until the fine is paid in full. It is also understood that any fighting in the league, before, during or after a match, may result in a ban from the league for the remainder of the season without refund. It is also understood that any violence against any referee or organizer of the league will result in a lifetime ban from the league without refund.
